Subject: New Format to End of Month Reports

Over the last several months, we have been sending new reports to every library's RSA Gmail account. These are intended to replace some of the legacy Workflows monthly reports that are unclear, outdated, or hard to read. The existing end of month reports were designed in 2007 to answer a required online circ and ILL form. That form was retired around 2010. Our other objective is to consolidate many of the old reports down into only a handful.

Here is the current list of new end of month reports and the names of the existing legacy reports they replace.
